REGISTRATION AND REFUND POLICIES

1. I/We understand families will be given a full credit for any canceled registrations (all families were contacted directly regarding any program cancellations). We will also honor the price you paid in 2022 for the same (or similar) program in 2023 and offer you early access to registering for our 2023 programs.
2. I/We understand refunds will not be made for camp days missed due to illness.

TERMS OF AGREEMENT

- A. I/We agree to allow my child to participate in all camp activities, and in any supervised trips or activities, on or off the camp property.
- B. I/We agree to release and indemnify Little Champ Camp from any and all claims for damages arising as a result of accident, injury, or otherwise sustained by the herein named child, arising from participation in any camp activities.
- C. I/We give permission to the staff of Little Champ Camp to seek medical assistance and treatment for my child in the event of an emergency, if parent or emergency designate cannot be contacted.
- D. I/We understand that the camp does not accept the responsibility for damage to, or loss of, personal belongings during the program.
- E. I/We understand that there is a late pick-up fee and agree to pay Little Champ Camp the following: \$ 10 for any part of each fifteen-minute interval after 4:00pm or 6:00pm (whichever hours your child is signed up for) will be charged at the time of pickup.

Swimming Release Form
